

THIRD AMENDMENT TO DECLARATION OF

COVENANTS AND CONDITIONS FOR INDIAN CREEK PHASE IV B

WHEREAS, the Declaration of Covenants and Conditions for Indian Creek Phase IV B, was recorded in Official Records Book 4367, Page 257, of the Public Records of Palm Beach County, Florida and subsequently amended ((hereinafter collectively referred to as the "Declaration") affecting certain real property as described therein; and

WHEREAS, the Declaration provides for amendment of the Declaration, as set forth herein.

NOW THEREFORE, the Declaration is hereby further amended as follows (additions to prior language are reflected by underlining, and deletions of prior language are struck through):

1. The following sentence shall be added to the end of Article V, Section 8, of the Declaration (regarding **Remedies of the Association**):

"Additionally, if a Unit Qwaer is in arrears to the Association for the payment of assessments or other amounts due the Association, upon notice by the Association to any tenant in such Unit, all rents shall be paid to the Association until such arrears are brought current. Every lease shall include a provision specifying the Association's rights to receive such rents from the tenant."

2. The following sentence shall be added to the end of Article VI, Section 1, of the Declaration (regarding **Enforcement)**:

"Additionally, the Phase IV B Association shall have the power to fine Owners for violations of any of the Covenants and Conditions, in accordance with the Florida Homeowners Association Act (Florida Statutes, Chapter 720)."
